This qualification meets the minimum education requirement for trainers and assessors operating without supervision under applicable VET legislation, frameworks and/or standards.


The course is designed for people currently working in industry and thus is delivered on a part time basis, other training options do exist, so please call us for other training options.

This course is offered over a 52 week period and comprising of 4 x 10 weeks term of one day per week in class and approximately 7 hours of private study each week.

Learners will be empowered to develop skills and gain knowledge in a broad range of areas to assist them to be fully equipped to function as a trainer and assessor in the VET sector.

Our course has been clustered to ensure that learners gain a holistic understanding of course design, training delivery and assessment practices for nationally recognised qualifications and accredited courses.

On successful completion, learners will gain a nationally recognised qualification in TAE40122 Certificate IV in Training and Assessment.



Our training staff are here to support you with mastering the material. Please be aware that a short test will be conducted on day one of the face to face training to confirm that you have mastered the pre-reading. Participants who have not mastered the pre-reading will be required to repeat the pre-reading before they can commence the face to face training component.

Assessment is conducted continuously during your training and takes the form of written (or verbal) theory questions, written assignments, and observation of your skills by our trainers.

The qualification is nationally recognised and can only be delivered by a Registered Training Organisation (RTO) that complies with the governing standards of quality control and quality training and assessment.

The Training industry regulators anticipate that qualified individuals will have a good level of English proficiency to clearly communicate with students, peers, supervisors and the workforce in general undertaking the role.

Applicants who do not have sufficient English Language skills will be referred to an English Language provider and encouraged to reapply for the course when their English Language skills have improved.
